

**WNNK-FM/ WINK 104 “Lunch with a WINK On-Air Personality at Café 1500”
Contest
Official Contest Rules**

A complete copy of these rules can be obtained at the offices of radio station **WNNK-FM/WINK 104.1**, owned and operated by Cumulus Broadcasting LLC (collectively, the “Station”), 2300 Vartan Way, Harrisburg, PA 17110, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the “Lunch a WINK On-Air Personality” contest (the “Contest”) substantially as described in these rules on the following Station website: www.wink104.com and by participating, each participant agrees as follows:

1. No purchase is necessary. Void where prohibited. All federal, state, and local regulations apply.
2. Only legal U.S. residents age 18 or older (or other designated age restrictions deemed by station) with a valid Social Security number at the time of entry and currently live in the and currently reside in Dauphin, Cumberland, Lebanon, Perry, York or Lancaster counties in Pennsylvania are eligible to participate in STATIONS CONTEST. Employees, agents, representatives, or affiliates of the Station, its affiliates, participating sponsors, other radio stations, television stations and print advertising companies serving the metro area, and their immediate family members and household members are not eligible to participate. The term “immediate family members” includes spouses, parents, siblings, grandparents, children, grandchildren and cohabiting significant others.
3. **Contest Date: Tuesday, March 27, 2018 – Sunday, June 30, 2018 (the “Contest Period”).**

How To Play: To participate in the contest: enter online at wink104.com, click on the Café 1500 banner and sign up and enter to win a chance to eat lunch at Café 1500 in Harrisburg, PA with a WINK 104 On-Air Personality along with 3 of your friends. After the winner has been contacted and agrees to the prize, lunch will be served at Café 1500 in Harrisburg the following Wednesday at 11:30 am. Time subject to change. Station is not responsible for lost, stolen, mutilated, destroyed, misdelivered, postage due, illegible, incomplete or untimely entries. Entrants may be disqualified at the sole discretion of the station. Failure to respond to Cumulus Media once winner has been contacted that they have won within 24 hours will result in another winner being chosen.

Prize(s): Lunch for 3 (includes appetizers, entrée and a dessert) at Café 1500, located at 1500 North 6th street, #101, Harrisburg, PA 17102. *If winner(s) choose to order an alcoholic beverage with their meal, they must order it separately and pay for it along with the tip on a separate tab.* Cumulus Media, Inc. will not pay for or supply alcohol. Prizes are not transferable, redeemable for cash or exchangeable for any other prize, except in sole discretion of the station. All prizes must be redeemed within 30 days of the contest end date unless otherwise specified. If a winner cannot be contacted or is disqualified, the Company reserves the right to determine an alternate winner or not to award that winner’s prize, in its sole discretion. The Company is not acting as the manufacturer or distributor of any prize awarded. The Company makes no warranties with respect to any prize. With respect to any claims for cancelled, postponed, or rained out concert, sporting event or show ticket prizes, winner should look to the provider or others in the chain of production and distribution but excluding the Station and the Company. If it is determined that the candidate is not eligible to receive the grand prize, in the Station’s sole judgment and discretion, another candidate will be selected for eligibility consultation and this process will continue on until such time as an eligible candidate is found. In the unlikely event that no candidates are found to meet the specifications, then the prize will go un-awarded. In the event of a tie, the winner will be determined by and at the Station’s sole discretion

4. All State, Local, Federal and or other taxes, duties, tariffs, title fees, licensing fees, or other fees for prizes awarded become the sole responsibility of the winner. All those who win a prize or prizes valued \$600 or more in any given year will be issued an IRS Form 1099 to report their winnings.

After such time, ownership of said prize reverts back to the Station to be disposed of at its discretion. The winner then loses all claims and rights to said prize.

As a condition to receiving the prize, any potential winner must complete and sign a Winner's Affidavit and Release, releasing the Station from all liability in connection with winner's participation in the contest and acceptance, use, or non-use of the contest prize.

All entry blanks, forms, devices, and materials gathered during the course of entry, as well as all information contained on or within, shall become the sole property of the Station to be used, disposed of or destroyed in its sole discretion. The Station is not responsible for any incorrect or inaccurate information entered by website users, and assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to the Station's website.

All entrants and winners agree to give the Station and its licensees, affiliates, successors, and assigns the irrevocable and unrestricted right to use, re-use, broadcast, or publish their name, city of residence, photo, video tape, film or any other likeness, including portraits and pictures, in whole or in part, as part of a composite, retouched or distorted in character or form, and winner's voice, recorded or live, for any reason the Station deems necessary without compensation, unless prohibited by law. All winners release, discharge, and agree to hold the Station harmless from any and all claims they may have against the Station in connection with the taking, production, or the use of winners' name, city of residence, any photo, video tape, film or any other likeness, including portraits and pictures, in whole or in part, as part of a composite, retouched, or distorted in character or form and without restrictions as to any changes, transformations or alterations, and including winners' voices, recorded or live. All winners further acknowledge that the Station owns or will own exclusively any photographs of such winners used for such purposes, including the copyrights in them, regardless of the form in which they have been or may be produced and used, and all winners assign all such ownership rights to the Station.
13. By participating in the Contest, each participant agrees to receive email communications from the Station regarding Station events and contests. Any participant that opts-out of these mailings will also remove themselves from the contest.

14. By participating in the Contest, participants agree to be bound by the decisions of Station personnel. Persons who violate any rule, gain unfair advantage in participating in the Contest, or obtain winner status using fraudulent means will be disqualified. Unsportsmanlike, disruptive, annoying, harassing or threatening behavior is prohibited. The Station will interpret these rules and resolve any disputes, conflicting claims or ambiguities concerning the rules or the Contest and the Station's decisions concerning such disputes shall be final. If the conduct or outcome of the Contest is affected by human error, any mechanical malfunctions or failures of any kind, intentional interference or any event beyond the control of the Station, the Station reserves the right to terminate this Contest, or make such other decisions regarding the administration or outcome as the Station deems appropriate. All decisions will be made by the Station are final. The Station may waive any of these rules in its sole discretion.
