

WNNK & WWKL'S "ASHLEY HOMESTORE GRAND OPENING REGISTER TO WIN PRIZE GIVEAWAY OCTOBER 9, 2021" CONTEST

OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WNNK and WWKL ("Station"), 2300 Vartan Way, Suite 130, Harrisburg, PA 17110, during available business hours Monday through Friday, on the Station websites www.wink104.com or www.hot1067fm.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the WNNK & WWKL's "Ashley Home Store Grand Opening Register to Win Prize Giveaway October 9, 2021" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number. **Void where prohibited by law.** Employees of Station, Cumulus Broadcasting LLC, Cumulus Radio LLC, and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

2. **Contest Period.** The Contest will begin at **12:00pm ET October 9, 2021, and will run through 5:30pm on October 9, 2021**, (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

3. **How to Enter Onsite.**

Attend the remote broadcast conducted by Stations at the Grand Opening Event of Ashley Furniture Home Store at 5950 Carlisle Pike, Mechanicsburg, PA 17050 on Saturday October 9, 2021 between 12:00pm ET and 5:30pm ET and complete an entry form. **Limit one (1) entry per person, per drawing, per remote broadcast.** All entries must be received by the deadline stated at the remote broadcast.

Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to verify winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded.

4. **Winner Selection.**

Beginning at 12:30pm ET and continuing every sixty (60) minutes until 5:30pm ET on October 9, 2021, Station will select two (2) potential winners in each drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in

disqualification and forfeiture of the prize.

A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. Station’s failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
