WNNK'S "DISNEY ON ICE ONLINE RTW TICKET GIVEAWAY - JAN 31-FEB 2, 2025" CONTEST OFFICIAL RULES

The Station will conduct the WNNK's "Disney On Ice Online RTW Ticket Giveaway - Jan 31-Feb 2, 2025" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Any attempt by any entrant to submit more than one (1) entry by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the entrant may be disqualified. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification and forfeiture of the prize.
