# WNNK'S "HIGHMARK WALK REMOTE REGISTER TO WIN AVRIL LAVIGNE CONCERT TICKETS -MAY 17, 2025"

## **CONTEST OFFICIAL RULES**

A complete copy of these rules can be obtained by contacting radio station WNNK ("Station"), 2300 Vartan Way, Suite 130, Harrisburg, PA 17110, during available business hours Monday through Friday, on the Station website www.wink104.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the WNNK's "Highmark Walk Remote Register to Win Avril Lavigne Concert Tickets - May 17, 2025" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF 1. WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number. Void where prohibited by law. Attend the remote broadcast conducted by Station at HACC, One HACC Drive, Harrisburg, PA 17110 on May 17, 2025 from 7:00 AM ET to 9:00 AM ET and complete an entry form. Limit one (1) entry per person per remote broadcast. All entries must be received by the deadline stated at the remote broadcast.

Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to verify winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded.

#### 4. Winner Selection.

Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.

- 5. Verification of Potential Winner.
