## WNNK'S "MOTHER'S DAY MATCH GAME MAY 5-9,2025" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WNNK ("Station"), 2300 Vartan Way, Suite 130, Harrisburg, PA 17110, during available business hours Monday through Friday, on the Station website www.wink104.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the WNNK's "Mother's Day Match Game May 5-9, 2025" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY. Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number. Void where prohibited by law. Employees of Station, Cumulus Broadcasting LLC, and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- 2. Contest Period. The Contest entry period will begin at 6:00am ET on May 5, 2025, and will run weekdays from 6:00am ET to 10:00am through on or about 8:40am ET on May 9, 2025, (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

## 3. How to Enter & Win:

Listen to the Station during the Contest Period. When the Station announces and/or plays the "cue-to- call" sounder, listeners must call the Station at 717-234-9465 or 1-800-WINK-104. Caller #10 will be chosen to participate, provided that their Mother or Daughter or Son must also be immediately reachable by phone to play the Match Game. In the event Caller #10's Mother or Daughter or Son is not immediately reachable by phone, or declines wanting to play the game, Station will advance to the next caller and repeat the process until a contest participate is determined. The Caller to the Station, as determined by the Station in its sole discretion, will be the winner for that Selection Day after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. **To qualify for the Grand Prize:** Participants must correctly match two (2) of three (3) answers in the Match Game. All entries must be played on the air. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

FOR GRAND PRIZE: On or about 8:40am ET on Friday, May 9, 2025, Station will select one (1) entry for the Grand Prize in a random drawing from among all valid entries received by Station during the Contest Period. In the event that none of the entries qualify for the Grand Prize by correctly matching two (2) of three (3) answers in the Match Game, the Grand Prize winner will be determined by a random drawing from all five (5) entries in the Contest regardless of the number of matching answers each gets in the Match Game. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the

Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize.

- 4. Verification of Potential Winner. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. Station and any Sponsors make no

Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

Station is not responsible for any incorrect or inaccurate information entered by website users, and assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to Station's website.
